Dear Mayor Osby Davis,

This is in response to your letter dated March 31, 2010, to 'cease and desist' from using your photos and/or images on our website or in any of our communications or publications.

We have thoroughly examined our website and all printed materials intended for dissemination to the public and have found no images, or photos or any official of the City of Vallejo. We have a video and pictures of our meetings which we showed in the HMF Presentation to the people of Mare Island to let them know we already have started the introduction of HMF to you as the Mayor of Vallejo. We will not use any of those materials without written permission and we don't have any intention to use those to promote HMF.

However, we did find several postings of the images that you referred to on the internet that were posted by Marc Garman of the Vallejo Independent Bulletin. We want to clarify that none of the images and/or information published by VIB were furnished by HMF, instead they were obtained by Marc Garman illegally during the HMF presentation in the Global Center for Success in Mare Island.

In all of HMF events, we have a strict policy against the use of any recording devices which is clearly explained to all attendees. That is why we conduct electronic and visual screenings of the invited guests. The reason for that policy is for everyone's protection so that incidents like this do not happen.

Marc Garman flagrantly violated that restriction. Thus, Mayor Davis, we believe that your grievance is with Marc Garman, not with HMF.

Though the H. MARTIN FOUNDATION Far East Humanitarian Services (HMF) hasn't gone public yet, the credibility of the H. MARTIN FOUNDATION Far East Humanitarian Services stands on its own merit in the highest level. We do not need nor ask for an endorsement from any

individual or entity to get recognized. Please check our website www.hmartinfoundation.org, more importantly the **HMF Disclosures and Disclaimers** page and the **Petition** page to have a better understanding of HMF.

Attached are copies of letters we prepared and recently sent to all the Mayors, Governors, Attorneys General and Secretaries of State all over the United States of America. HMF is serious in our commitment to help the people of the world. Time will come and justify that Marc Garman is misinformed and has an underlying motive to discredit H. MARTIN FOUNDATION Far East Humanitarian Services.

We regret for the misunderstanding Marc Garman's twisted allegations has cause you to change position regarding HMF. We were under the impression that you were in favor of the HMF Vision and Mission that will provide humanitarian services to the poor, working poor and the people of the city of Vallejo. To comply with and respect your statement of non-support of HMF, we regretfully rescind the plan to make Vallejo the first HMF Model City Project in the United States of America.
